# **About Us**

Western Alliance Academic Health Science Centre (Western Alliance) was established in 2014 and incorporated as a registered health promotion charity (Western Alliance Health Research Ltd) in 2016. It is Australia's first rural and regionally focused academic health science centre.

In 2021, Western Alliance received NHMRC 'Emerging Research Translation Centre' status in recognition of our work in research translation, research excellence and workforce development, as well as building capability/capacity in research and research translation.

Western Alliance is comprised of 11 member organisations located across the Barwon/Southwest and Grampians regions of western Victoria. Members include eight public health services, a primary health network and two universities. The two regions have a combined population of over 700,000 residents or approximately 44% of rural/ regional Victoria's population.

Western Alliance supports the development of healthier regional and rural communities. This is in recognition of the significantly poorer health outcomes experienced by people living in the Barwon/South West and Grampians regions of Victoria compared to their metropolitan counterparts. The challenges that affect the health of people living in western Victoria include distance and major variations in access to healthcare, lower socio-economic status and poorer infrastructure.

The key function of Western Alliance is to support the development of the capability and capacity of our members to conduct research relevant to regional health and to support the implementation of research-based and evidence-informed healthcare across western Victoria. Western Alliance has established important collaborations with leading national and state-based organisations to improve our capacity to support research in our priority themes.

To date, Western Alliance has supported **72 health** research translation projects, including flagship research projects, project grants, scholarships, seed funding and financial contributions to large NHMRC-funded projects.

In addition, Western Alliance is a lead organisation in the DELIVER project (Delivering Enhanced heaLthcare at home through optlmising Virtual tools for oldEr people in Rural and regional Australia), a five-year, \$9 million Medical Research Future Fund (MRFF) research project that is identifying and building a suite of programs to improve and extend in-home healthcare and is further building health research capacity and capability across the region.

# Our Research Priorities

In 2023, Western Alliance member health services and the Western Victoria Primary Health Network (PHN) completed a survey to identify priorities that could be addressed through translational research and/or research translation. These data were analysed and collated using a modified Delphi approach. From this, an integrated list of priorities was developed with input from Board members and members of the Western Alliance Research Translation Committee.

This approach allowed for the recognition of diverse perspectives to arrive at a high level of agreement.

# **Our Funded Studies**

Since its establishment, Western Alliance has funded 72 research translation projects in alignment with our identified research priorities. The Alliance has contributed \$2.95 million to these studies, which have attracted over \$26 million in external funding. These include:

# Our Structure

Western Alliance operates as a company limited by guarantee and is registered with the Australian Charities and Not-for-profits Commission (ACNC).

Management leadership of Western Alliance is provided by the Executive Director, Professor Warren Payne and Chief Operating Officer, Mr Drew Aras. Mr Aras is registered as the Alliance's Company Secretary and Mr Dale Fraser, CEO Grampians Health, is the Alliance's Treasurer.

# Western Alliance Organisational Structure

#### **Board of Management**

Western Alliance is an Incorporated Association and Registered Charity, governed by a Board of Management. The Board is comprised of the CEOs (or representatives) of each member organisation along with four Directors who have been appointed based on their skills or background.

The Board meets bi-monthly at which time it receives financial reports, including long term (three year) financial projections to monitor sustainability and progress.

#### Research Translation Committee

The Western Alliance Research Translation Committee, established in 2019, is a standing sub-committee of the Western Alliance Board. The Research Translation Committee includes individuals from its member organisations who have strong clinical and/or research skills as well as an Aboriginal representative and two consumer representatives.

# DELIVER Program Governance Subcommittee

The DELIVER program management reports to the Western Alliance Board via a Board sub-committee which is comprised of Board members and DELIVER management. The DELIVER program is led by the Western Alliance Principal Research Translation Investigator and Director of the Deakin University Institute for Health Transformation, Professor Anna Peeters AM and is managed by Associate Professor Kate Huggins.

DELIVER has 23 Chief Investigators and its internal governance structure includes an Investigator Leadership Committee, five working groups and an external Advisory Committee. Aboriginal leadership within DELIVER is provided by the involvement of an Aboriginal researcher, Fiona Mitchell, as one of the Chief Investigators while consumer engagement has been facilitated by the appointment of a Consumer Liaison Officer. The DELIVER governance bodies include a balance of health service, primary care, and academic members.

# Chairperson's Report



Western Alliance has worked hard to further consolidate its activities, as well as implement a range of exciting new initiatives during the 2023/2024 financial year.

We undertook an extensive process to develop our Strategic Plan 2023-2026 and to refresh our research priorities. Our activity during this financial year strongly aligns with this plan and will continue to do so over the next two years.

#### Highlights during the year included:

- Strengthening our consumer and community involvement and advancement of Aboriginal-led research, including the appointments of Katherine Stanley and Associate Professor Nicole Mercer to the Western Alliance Board as consumer and Aboriginal representatives respectively, continuing support of CARN (Community and Research Network), becoming a member of the Lowitja Institute, (Australia's only Aboriginal and Torres Strait Islander community controlled health research institute), and aligning Western Alliance activities with the newly launched marra ngarrgoo, marra goorri (The Victorian Aboriginal Health, Medical and Wellbeing Research Accord).
- Allocating over \$300,000 in funding to 13 translation-focussed health research projects across western Victoria, with four of these projects attracting a further \$9.55M in external grant income.
- Allocating \$90,000 to two Higher Degree by Research (HDR) Fellows.
- Further expansion of our STaRR (Supporting Translation of Research in Rural and Regional Settings) capability building program, which supported training for over 120 emerging researchers across the region.
- Expanding the Australian Clinical Trials Education Centre (A-CTEC), which now provides free, high quality clinical trials training to over 8000 members of the clinical trials workforce in Australia (including over 300 from Western Alliance member organisations).
- Showcasing over 40 local research translation projects to over 120 health professionals, research and community members at our annual symposium in Warrnambool.

I would like to thank all our member organisations for your ongoing support of Western Alliance. I thank all members of our Board and Research Translation Committee, particularly Professor Gabrielle O'Kane, Ms Alison Verhoeven and Ms Samantha Sharp, who stepped down during the year, and welcome new Board members, Ms Katherine Stanley and Associate Professor Nicole Mercer.

I look forward to continuing to work with you all as we pursue our vision of healthy rural and regional western Victoria communities benefitting from evidence-based and research-informed healthcare

#### **Our Activities**

Each of our activities align with our four strategic objectives across our research priorities:



# DELIVER (Delivering Enhanced healthcare at home through optImising Virtual tools for oldEr people in Rural and regional Australia)



Western Alliance, as the lead organisation, in partnership with the Deakin University Institute for Health Transformation, Monash University and the University of Melbourne, was awarded a 5-year, \$9 million research project grant by the Federal Government Medical Research Future Fund (MRFF) in late 2021.

The DELIVER project brings together, for the first time, rural healthcare providers, consumers, academic health science centres, universities, and national peak bodies to:

1. improve healthcare at home for older people in regional and rural areas using rapid research

translation, digital tools and co-design; and

2. implement a sustainable capacity building model to support rapid research translation for regional and rural health services.

Since being formally awarded the MRFF grant in early 2022, the DELIVER team have built the foundations of the project and have moved into the co-design and priority setting phase, where the team is working with health service representatives and consumers to build understanding of the home-based healthcare and research systems, and to identify opportunities for the DELIVER research team to support evaluation and practice innovation.

#### Other activities include:

- development of a new rapid evidence summary process whereby embedded researchers develop evidence syntheses tailored to critical health service questions to support service delivery improvement and innovation;
- an insights study to understand priority aims for remote patient monitoring has commenced;
- commencement of systems mapping workshops across the Barwon South West and Grampians regions to identify factors that increase uptake of home-based care and local solutions;
- administration of the internationally validated Research Culture and Capability survey across the region's health services;
- commencement of a webinar series, featuring the Victorian Department of Health on their digital health strategy, Dr Olivia Metcalf on the state of the evidence for remote patient monitoring, A/Professor Michelle Callisaya on lessons learned undertaking co-design with older people with dementia and Dr Shannon Nott on embedding virtual care in rural and regional healthcare;
- launch of the DELIVER website;
- completion of several evidence syntheses to inform capacity building training and working with consumers;
- building of site investigator teams and appointment of DELIVER research and translation staff; and
- staging the DELIVER Showcase as part of the Western Alliance Symposium, followed by the DELIVER All-Investigator Day.

#### Australian Health Research Alliance (AHRA)



Western Alliance has been recognised by the NHMRC (National Health and Medical Research Council) as an Emerging Research Translation Centre.

This recognition has occurred as part of a rigorous accreditation process and enables Western Alliance to become a member of AHRA (the Australian Health Research Alliance). AHRA members include all NHMRC accredited Australian Research Translation Centres. This has provided Western Alliance with access to a wealth of opportunities for collaboration and sharing of expertise, as well as access to further funding opportunities.

We are extremely proud to represent Western Victoria in working towards better health through translational research and look forward to working with our peers across Australia as we prepare for full NHMRC accreditation over the coming year.

Membership of AHRA has enabled Western Alliance and its members to participate in significant AHRA coordinated research translation projects. Western Alliance is currently participating in a Medical Research Future Fund funded Consumer and Community Involvement project by extending the consultative process into western Victoria.

Membership of AHRA has also enabled participation in AHRA's national collaborative programs including the Women's Health Research Translation and Impact Network, the Consumer and Community Involvement Initiative, the Indigenous Research Network (OCHRe - Our Collaborations in Health Research), and the Data Driven Healthcare Improvement Initiative.



#### Victorian Research Translation Centres Collaborative (VRTCC)







In early 2020 the three Victorian Research Translation Centres, the Melbourne Academic Centre for Health (MACH), Monash Partners and Western Alliance, formed a collaborative to produce and translate evidence to improve the health of Victorians – The Victorian Research Translation Centres Collaborative (VRTCC). Over 95% of health and medical research in Victoria is conducted by the members of these centres, and the role of the Collaborative is to embed research into healthcare.

#### VRTCC drives several key programs including:

The VRTCC Victorian Falls Prevention Alliance, which was established in November 2021 and includes representation from consumers, clinicians, researchers, managers and policy makers across Victoria. The purpose of the Falls Prevention Alliance is to work collaboratively to reduce falls and injuries from falls in hospitals. Each year the Alliance holds a workshop addressing a

key focus area in falls prevention. Each workshop provides an opportunity to meet experts and share experiences, as well as providing clinicians with practical tips to reduce falls in their location of practice.

- The Australian Clinical Trials Education Centre
   (A-CTEC), formerly the Victorian Clinical Trials
   Education Centre. A-CTEC is a not-for-profit,
   member-based education centre that has made
   learning resources for clinical trials accessible to
   more than 8000 researchers in health service
   settings across Australia. The A-CTEC Steering
   Committee is chaired by Western Alliance.
- The Victorian Research Governance
   Streamlining Working Group, which is
   undertaking a Victoria-wide review of research
   ethics and governance procedures including a
   specific focus on issues facing rural and regional
   health services.

#### National Ageing Research Institute (NARI)



Melbourne Ageing Research Collaboration Western Alliance and NARI, through the Melbourne Ageing Research Collaboration (MARC), have been jointly supporting and funding research since 2019.

In addition to partnering on research training initiatives, this year we have co-funded a rural ageing focussed project based in Ararat: The SWELL-RAC (Supporting the wellbeing of staff caring for residents with challenging behaviours in residential aged care) project. SWELL-RAC is currently working with residential aged care staff to develop new workforce wellbeing initiatives. This project intersects with our priority theme of Mental Health and is set to have a positive impact in the Grampians region.

# Murdoch Children's Research Institute (MCRI) G E N V

In 2021, MCRI commenced 'GenV', a large-scale project across Victoria centred on parallel birth and parent cohorts. Through representation on the GenV National Strategic Partnerships Advisory Committee, Western Alliance is actively supporting this program across western Victoria.

Through the GenV program, MCRI are also partnering on the Western Alliance Flagship Research Program - 'The Pregnancy Research and Translation Ecosystem (PRT-E)', led by Professor Peter Vuillermin. We look forward to continuing the progress of GenV over the coming years and to working collaboratively with MCRI to improve child and parent health for our communities.

Western Alliance also recently accepted an invitation from MCRI to become a financial partner to develop a submission to the Victoria Government to establish a Collaborative Centre for Infant and Child Mental Health and Wellbeing.



Western Alliance has participated in a research translation partnership with the Victorian government since 2019. The partnership has included the provision of strategic advice as well as funding for projects that address the strategic needs of both the government and Western Alliance member organisations.

Our partnership with the Victorian Department of Health continues to provide crucial support for the Research Translation Coordinator program, and this year our partnership has also facilitated a PhD Fellowship program with our member Universities.

The PhD Fellowship program enables health practitioners to undertake PhD study on a Department priority topic, by allocating funds to supplement a university PhD scholarship to enable the recipient to continue their professional work while undertaking their PhD.

Western Alliance was allocated two Fellowships (\$138,000 in total) this year, with participants to be enrolled in PhD programs via Western Alliance members Deakin University and Federation University.



Western Alliance recognises the importance of demonstrating cultural humility and agility as an organisation, whereby it is responsive to the needs of the Communities it serves, and privileges Aboriginal leadership, recognising Community strength and amplifying their voice, ensuring that its processes and language reflect a strengths-based approach.

During 2023/24 we undertook the following exciting projects and actions:

Following the launch of marra ngarrgoo, marra goorri: The Victorian Aboriginal Health, Medical and Wellbeing Research Accord, in late 2023 all Western Alliance funded grant applications for 2024 and beyond are required to demonstrate how proposed projects are informed by and address the specific health needs of western Victoria's Aboriginal communities and uphold the principles of marra ngarrgoo, marra goorri.





A/Professor Nicole Mercer

A/Professor Nicole Mercer was appointed to the Western Alliance board. A/Professor Mercer is a Wadawurrung Woman, with ties to Wurundjeri Nation, and has worked in acute and community public health settings and in Aboriginal health for over 25 years as a Registered Nurse. Her role on the Board is to provide strategic advice and oversee the implementation of research translation strategies to advance the health of the Aboriginal Community in western Victoria.


We have been accepted as a member of the **Lowitja Institute**, Australia's only Aboriginal and Torres Strait Islander community-controlled health research institute, and look forward to continuing our efforts through this membership to advance Aboriginal led research in our region.

Western Alliance has committed to champion and work with the Western District Aboriginal Controlled Community Organisation (ACCO) Collective (WDAC), which includes western Victoria's eight ACCOs and represents 28% of Victoria's Aboriginal people, the largest Aboriginal population in regional Victoria. As a first step towards working with WDAC, Western Alliance is funding a collaborative research initiative led by WDAC, in partnership with Alliance members Deakin Rural Health and Grampians Health under the Centre for Australian Research into Access (CARA).

Western Alliance has supported or participated in additional regional, state and national programs and initiatives including:

- Involvement of Deakin University's National Indigenous Knowledges Education Research and Innovation (NIKERI) in mentoring and teaching into the STaRR Program)
- Supporting development of an Aboriginal consumer and community involvement network
- VACCHO (Victorian Aboriginal Community Controlled Health Organisation)
- OCHRe: Our Collaborations in Health Research

#### Annual Symposium, Warrnambool

The 2023 Western Alliance Symposium, held in Warrnambool, provided a wonderful opportunity to reconnect with colleagues and forge new collaborations, while showcasing some of the outstanding research across western Victoria. A total of 115 attendees enjoyed hearing 4 keynote presentations from leaders in regional and rural health and research, as well as 40 presentations from senior and emerging regional researchers.

Western Alliance recognises the importance of ensuring that consumers and the community have opportunities to be involved in the design and implementation of health research. During 2023/24 we instituted a process of appointing key people and establishing programs to facilitate meaningful consumer and community involvement across our region. These activities include:

- Appointment of Mrs Marilyn Dolling as a Consumer Representative on our Research Translation Committee. Marilyn provides a lived experience consumer and carer perspective in the co-development of Western Alliance initiatives.
- Appointment of Ms Katherine Stanley as a Consumer Representative on the Western Alliance board. Katherine has a lived experience of endometriosis and is the director of Endo Help Foundation which advocates for investment and improvements in women's health and raises money to support research into pelvic pain. Katherine's role on the Board is to provide a consumer voice and perspective for Board discussions and decisions, and to provide guidance on how best to support consumers to be involved in research and translation.
- Appointment of Ms Sarah Healy as the inaugural McIntosh Community and Research Network (CARN) Engagement Officer, co-developed and co-funded by Western Alliance and the McIntosh family in response to the passing of Mr Mishka McIntosh, whose passion for community engagement and recognition of the importance of

lived experience will continue through this role. The role has been created with the goals of continuing to develop CARN, and growing a network of researchers, consumers and others with an interest in the benefit of a lived experience voice in research and research design.

- Western Alliance collaboration with and co-funding of CARN, the main grouping for consumer and community involvement in research in western Victoria. Western Alliance has established and continues to fund a Lived Experience Coordinator position which oversees this network.
- Developing a program of consumer review of applications for research funding, including identifying appropriate consumers via the CARN network, providing training, support and debriefing for the consumer, and renumerating the consumer for their time. The goals of this program are to ensure that consumers participate in decisions on what research and translation projects Western Alliance supports, and to provide consumer feedback and advice to applicants to strengthen the consumer and community involvement in their research projects.
- Improving carer involvement in research and translation activity across western Victoria, through becoming a financial partner in the newly created Deakin University 'Carer Hub' as part of the Centre of Excellence in Cancer Carer Research. Western Alliance will be represented on the Advisory Committee for the Hub.

Our Research Translation Coordinators, Dr Ella Ottrey, Dr Michael Field, Dr Jessie Adams, and Alesha Sayner, have established themselves as an integral component of research capability building in western Victoria.

Commencing in early 2019, the positions, which are funded by Western Alliance with the generous support of the Victorian State Government, are embedded in

Western Alliance member health services to provide 'boots on the ground' support for research development and translation.

This year our Research Translation Coordinators were instrumental in supporting and enabling many research and translation initiatives across the region, and led or supported 'Research Day' events across our member health services.



#### Showcasing research and supporting strategy development

Western Alliance supported the development and delivery of successful 'Research Day' events at South West Healthcare, Western District Health Service and Colac Area Health, and development of strategic research plans across multiple health services and the Primary Health Network.

# Objective: Capacity & Capability Building

#### STaRR (Supporting Translation of Research in Rural and Regional Settings)

STaRR has had its most successful year, training and supporting more emerging researchers and research mentors to enhance research capacity in our member organisations.

#### STaRR Emerging Researcher Training

A huge congratulations to our 2023 - 2024 STaRR Emerging Researcher cohort who completed their training. We are heartened by the engagement and enthusiasm of our emerging researchers and will continue to support and watch them with great interest. We would like to thank our fabulous STaRR mentors, workshop presenters, and facilitators for their invaluable contributions to and support for the STaRR program.

During 2023/24 the STaRR program enabled:

- 30 Emerging Researchers to complete the three STaRR workshops;
- 6 STaRR Emerging Researchers to present at the STaRR Showcase at the Western Alliance Symposium;
- 6 STaRR Emerging Researcher Grants to be awarded – 3 seed grants and 3 translation grants;
- 41 members of the STaRR Mentor Network to support STaRR emerging researchers; and
- 14 STaRR Emerging Researchers to participate in our inaugural Implementation Science workshops.

#### STaRR Emerging Researcher Showcase

The annual STaRR Emerging Researcher Showcase was held during the Western Alliance Symposium in November 2023. The audience was impressed with the excellent presentations delivered by five emerging researchers on their findings and learnings to date. We are thrilled that this event was once again a crowd favourite during the symposium, and we look forward to running it again in years to come.

Mentoring is a fundamental part of the STaRR
Emerging Researcher training program. Our STaRR
Mentor Network comprises over 40 health service and
academic researchers who volunteer their time to
provide one-on-one support and guidance to a STaRR
Emerging Researcher as they participate in the
10-week training program.

Our mentors are mainly from western Victoria, with a small number from metropolitan Melbourne and other locations, who have an interest in rural health or connections to the STaRR program.

#### HDR (Higher Degree by Research) Fellowships

This exciting initiative provides fellowships of \$45,000 to minimise barriers to health professionals undertaking health sector embedded HDR studies whilst continuing professional practice.

Cara Hill (pictured, left), who will complete her PhD with Deakin University on best-practice meal-related dysphagia interventions to improve mealtime-related quality of life for people living with dysphagia in rural and regional aged care facilities in western Victoria. Cara works as a speech

pathologist and as a research assistant. Her PhD program will be based at Grampians Health and will complement the work she will lead supported by a Western Alliance Rapid Applied Research Translation Grant.



Michael Pang (pictured, right), a senior clinician physiotherapist from Grampians Health, will complete his PhD with Federation University investigating whether continuing professional development positively influences allied health workforce retention in regional and rural Victoria.



A-CTEC now provides free access to clinical trials training for over 300 staff from Western Alliance member organisations and 8000 people across Australia, and is supported by funding from all state and territory governments.

The A-CTEC Conference was held in in May 2024, and featured two days of thought-provoking presentations and panel discussions with industry professionals and expert speakers on the theme "Better Together."

The Rapid Applied Research Translation Grants program focuses on supporting the translation of existing research and evidence into policy and practice, through implementation and/or scaling within health settings. A total of \$100,000 (up to \$40,000 per project) was allocated in the first iteration of this program during 2023/24.

#### Support for Major External Research Grants

During 2023/24 Western Alliance continued its successful program supporting applicants of major external grant opportunities, where the objectives of the proposed project align with those of Western Alliance and its member organisations.

We are pleased to report that four projects supported by Western Alliance were successful in external grant rounds during 2023/24. These projects were each allocated \$20,000 and collectively attracted \$9.55M in external competitive research grant income.

# A Western Alliance success story: Cara Hill



#### 2019

As a junior Speech pathologist at Colac Area Health Cara participated in the 2019 Allied Health Research Training Program (pre-STaRR), supported by Western Alliance, and pitched an idea to reduce adverse incidents in aged care due to incorrect food and fluid texture prescription

#### 2020 - 2021

Cara conducted the research at Colac Area Health, supported by Dr Laura Alston (Western Alliance Research Fellow) and Dr Michael Field (Western Alliance Research Translation Coordinator). Based on the research, health service policy was changed and prescription accuracy improved significantly.

#### 2021 - 2022

Cara completed the STaRR program to further her research skills and set up longer term evaluation and improvement of the research at Colac Area Health, as well as commencing similar work at Barwon Health and Grampians Health.

#### 2022 - 2023


Across 2022 and 2023, Cara received two Western Alliance grants (Emerging Researcher Grant and a Translation Grant) and a PhD scholarship, which will see her scaling the work across other Western Alliance Health Services.



During 2023/24 Western Alliance leveraged member contributions to significantly enhance access to research and translation funding for our member organisations. We have established an ecosystem for achieving improvements in health policy and practice across western Victoria based on our research priorities, and will continue to build on this in future years.

High priority future activities will include:

- working towards full NHMRC accreditation as a Research Translation Centre;
- growing our Consumer and Community Involvement program;
- continuing to strengthen partnerships with Aboriginal Community and advance Aboriginal led research translation and capability building;
- further expanding our STaRR Program to target health professionals at different stages of their research journey;
- further strengthening the connections between quality improvement and research across the region; and
- building on our strong existing partnerships with other research translation centres, the state government, MCRI and NARI, and exploring new partnerships across Victoria and Australia.
